Green Businesses Are Good Neighbors

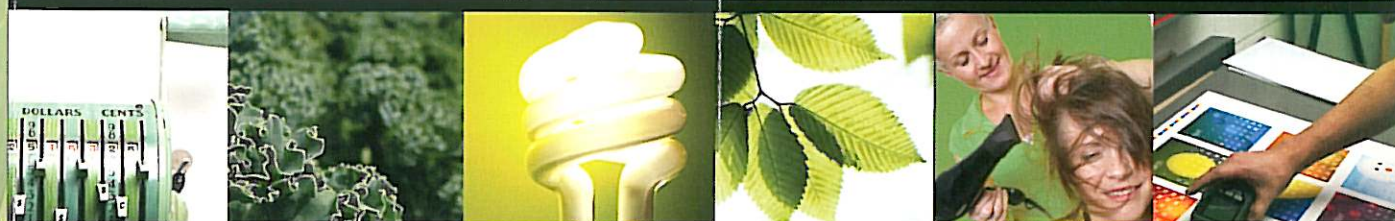
Green businesses assist communities. Green businesses and government agencies work to achieve environmental, public health and business retention goals.

1 Contact your county or city Green Business
Program Coordinator. A real, live person will
answer your questions and help you through
this process.

2 You will receive an easy-to-use checklist that
offers a variety of green business practices.
Many of these activities are things you are
already doing, and you can then choose a
minimum number to implement to achieve
Green Business Program Certification.

3 Green Business Program staff and technical
experts will visit your business to review your
"beyond compliance" practices. Free techni-
cal assistance is provided during this visit and
in follow-ups to help you implement the Green
Business practices that make sense to you.
